## SBC 1000 SBC 2000 Older Generation ASM SBA End of Product Sale (EOPS) Notification

Ribbon Communications is announcing the End of Product Sale (EOPS) for SBC 1000 & SBC 2000 SKUs with <u>older generation ASMs</u> (Application Solutions Modules). This announcement will effectively remove the impacted SKUs from the Ribbon Communications catalog and will no longer be available for purchase.
